# **IDENTITY** SOLDIERS OF THE CANADIAN EXPEDITIONARY FORCE Intermediate and high school version

#### OVERVIEW

In this lesson, students will use primary source material to create a picture of some of the Canadians who participated in the First World War.

#### **GRADE LEVELS:**

7 to 12, Secondary 1 to 5 in Quebec

#### **CURRICULUM CONNECTIONS:**

Social Studies; History; Language Arts; Media Arts; Geography

#### **ESTIMATED TIME:**

3-4 class periods

#### **OBJECTIVES**

Students will:

- Use primary source material to learn about Canadian soldiers during the First World War;
- Develop an appreciation of the diversity of the Canadian Expeditionary Force.

## MATERIALS REQUIRED

#### Important:

The First World War discovery box includes both authentic artifacts from the First World War (about 100 years old) and high quality reproductions of objects from the First World War (made more recently). All objects, whether authentic or reproduction, should be treated with care.





## LESSON

## PART A – INTRODUCTION

Discuss as a class Canada's response to the outbreak of the First World War.

- Who were the people of Canada in 1914? Talk about immigration, First Peoples, Confederation, urban living vs. rural.
- What kinds of jobs did Canadians have?
- Why did Canada participate in the First World War?
- What were the motivations of the individuals who volunteered for the war?

Approximately 619,000 Canadians went overseas to fight during the First World War. For every Canadian who signed up to participate, an attestation paper was completed. These forms have been preserved at the Library and Archives Canada and all have been digitized and are available for consultation online. These forms can tell us a lot about the people who fought for Canada during the First World War and what life was like in Canada at the time.

Note: Library and Archives Canada holds microfilm copies of the military personnel files of the Royal Newfoundland Regiment and Newfoundland Forestry Corps. These files have been digitized by **The Rooms** and are available for consultation online.

#### PART B – ATTESTATION PAPER

Display the image of **Appendix 1 – Attestation Paper** for the class using an interactive whiteboard. Alternatively, display via overhead projector or distribute photocopies for student to examine.

As a class, go through the document and discuss the information provided. Use the questions in **Worksheet 1 – Service Personnel Information** to extract the relevant information.

Continue your analysis of the document with the following questions:

- Based on the answers given by the solider at the time of enlistment, what inferences can be made about his pre-war experiences?
- Why would the military want to know a soldier's marital status?
- Would participation in a militia have been considered an advantage?
- What can the soldier's pre-war occupation tell us about his experience, skills or character?
- Why does the soldier swear an oath to "His Majesty King George the Fifth"?
- Why would the military want to know a soldier's religion?
- What might disqualify a man as "unfit"? (poor teeth, flat feet, too short)

#### PART C – ENLISTMENT

Divide the class into pairs and distribute copies of **Worksheet 2 – Blank Attestation Paper**. Have students take turns playing the role of the recruitment officer and the enlisting soldier. Are there questions that are difficult to answer or that may not seem relevant today? Why?

## PART D – SOLDIER'S PHOTO ALBUM

Attestation papers offer only a glimpse of a snapshot of a soldier's experience at the time of his enlistment. To get a more complete picture of solider of the CEF, additional sources are required. Researchers may consult service personnel records, war diaries, personal items such as letters, photos or souvenirs, newspaper articles, etc. The Canadian War Museum holds many of these records and artifacts. In the case of Will van Allen, subject of the English attestation paper included as Appendix 1,<sup>1</sup> his wife donated three of his Albums to the museum. The selection of images in the reproduction photo album contained in the Discovery Box tell Will van Allen's story.

Display the PDF of the Soldier's Photo Album on an interactive whiteboard. Alternatively, display via overhead projector or distribute photocopies for students to examine.

Explore the photo album as a class and discuss the additional information we can learn about Will van Allen based on his photos, captions and ephemera.

What questions do you still have about Will van Allen? Where might you begin searching for answers?

#### PART E – SOLDIER RESEARCH

Encourage students to conduct their own research by evaluating the attestation papers of other soldiers and nurses. You may choose to use the examples provided in **Appendix 2 – Additional Attestation Papers**, or choose your own. You may choose to have students review attestation papers from your community or province. Alternatively you may choose attestation papers from across the country to get a more diverse picture of the Canadians who made up the CEF.

Digitized copies of attestation papers can be found via the Library and Archives Canada, Soldiers of the First World War, 1914-1918 Database or on *The Rooms* website in the case of the soldiers from Royal Newfoundland Regiment.

Have students work in groups of 3 or 4 to complete **Worksheet 1 – Service Personnel Information**. Note that students may require assistance in deciphering handwriting.

#### **EXTENSION ACTIVITY:**

- Have students conduct more in-depth research by exploring complete service personnel records. Many files can currently be accessed online through the Library and Archives Canada, Soldiers of the First World War database.
- Based on the research conducted in Part E, have students imagine what might have been the experience of this soldier and create a fictional scrapbook. Use images from Canada and the First World War and from the Canadian War Museum's <u>Military History Research Centre</u> database.

<sup>1</sup> Note: Will van Allen's attestation paper is available in English only. When doing this activity in French, you can use the French attestation paper as an example, and then continue with the story of Will van Allen using the photo album, which has been translated.

#### DECLARATION TO BE MADE BY MAN ON ATTESTATION.

I....., do solemnly declare that the above are answers made by me to the above questions and that they are true, and that I am willing to fulfil the engagements by me now made, and I hereby engage and agree to serve in the Canadian Over-Seas Expeditionary Force, and to be attached to any arm of the service therein, for the term of one year, or during the war now existing between Great Britain and Germany should that war last longer than one year, and for six months after the termination of that war provided His Majesty should so long require my services, or until legally discharged.
